# Important information: changes to strategic asset allocations, standard risk measurements, and fees and costs.

# 1. Changes to Strategic Asset Allocations

On **30 September 2022**, we made changes to the Strategic Asset Allocation (SAA) for six of our diversified (readymade) investment options: MySuper, Balanced, Conservative Balanced, Stable, Secure and Socially Responsible.
